# Mental Health Consultation Bid for EOA Children's Services

This document is a request from EOA Children's Services for proposals from a licensed or certified mental health professional with experience working with young children and their families.

### **Background**

EOA Children's Services provides high-quality preschool education to children in Northwest Arkansas. We have eight preschools throughout Washington County and one Administrative Central Office, which is located at 1643 E. Huntsville Rd, Fayetteville AR 72701.

# **Scope of Work**

Under the three-year contract to be awarded through this RFP, EOA Children's Services seeks a professional, experienced, licensed Mental Health Professional to provide programmatic support, consultation, and therapeutic direction to teachers, children and families. Services are expected to primarily take place during the months of September through May of each school year. Consultation services shall include the following:

- Facilitate one Mental Health Family Day for each of the eight pre-school centers throughout Washington County (3 centers in Springdale, 4 centers in Fayetteville, 1 center in Lincoln). Approximately 1 hour per family day.
- Observe 34 classrooms bi-annually for approximately 45 minutes each and provide constructive feedback regarding teacher-child relationships, classroom operations, etc.
- Provide bi-monthly Reflective Group Supervision to teachers in the Pat Walker Center for Children during the months of September-December then monthly supervision from January-May of each school year.
- Facilitate individualized trainings as requested on topics related to child and family mental wellness.

### **Response Criteria**

Response to this RFP will require the individual or agency to provide sufficient information to determine that the individual or agency qualifies for performing the services required, including the following:

- Address your overall capabilities as they relate to your company's ability to meet the needs outlined in the Scope of Work.
- Describe fee structure and billing procedures. If the bidder estimates a cost adjustment between years 1 and 2 or years 2 and 3 of the contract, the estimated adjustment should be listed in the bid. If any portion of the fee or rate will be donated, it must be clearly stated in your fee structure.

- Present three references including names, addresses, titles, phone, and e-mail addresses of the person(s) most familiar with the work performed.
- Must be able to complete classroom observations between the hours of 8 am-12 pm. Must be able to facilitate Mental Health Family Days on selected Fridays from 12-1. Must be able to provide group supervision in the afternoon from approximately 2:15 to 3:30 pm.
- Proof of Liability Insurance including Workmen's Compensation if utilizing employees

#### **Selection Criteria**

The following criteria will be used to evaluate the qualifications of the business:

- Capability to perform the required services for EOA Children's Services
- Professional background and experience
- Cost of services
