Background

EOA Children's Services provides early childhood education and comprehensive services to economically disadvantaged children and families in Northwest Arkansas. Scope of Work

Under the three-year contract to be awarded through this RFP, EOA Children's Services seeks a professional, experienced business to conduct landscape maintenance. We are requesting two main areas of work. You may submit your proposal for one OR both areas:

- 1. Lawn and Landscape Maintenance (3 locations in Fayetteville, AR; 3 locations in Springdale, AR; 1 location in Lincoln, AR)
 - Mowing, trimming, edging the grass during the growing season
 - Blowing off all walkway areas
 - Pruning shrubs in a manner to promote the correct growth habits for each species
 - Installation of hardwood mulch to all beds
 - Removal of any debris from performed work
- 2. Chemical Application (1 location in Springdale, AR)
 - Applications of fertilizer, weed pre-emergent and post-emergent to the turf and landscaped beds
 - All chemical applications must meet the health and safety requirements for the population that we serve at our facility

Response Criteria

Response to this RFP will require the business to provide sufficient information to determine that the agency qualifies for performing the services required, including the following:

- Address your overall capabilities as they relate to your company's ability to meet the needs outlined in the Scope of Work.
- Submit a list of any tasks that will be subcontracted and a list of the subcontracting firms. EOA Children's Services reserves the right to approve any sub-contractor of the lead contracting firm's team.
- Describe fee structure and billing procedures.
- Present three references including names, addresses, titles, phone, and e-mail addresses of the person(s) most familiar with the work performed.
- Proof of Liability Insurance including Workmen's Compensation if utilizing employees
- Must Maintain a Physical Business Address and Phone Number
- Must be able to complete the scope of work Monday-Friday between 7am-9am OR any time after 2pm, in compliance with city noise ordinances.
- Chemical applications <u>must</u> be scheduled after 4pm to reduce exposure to children. Proof of licensure to apply chemicals must be presented at time of bid.

Selection Criteria

The following criteria will be used to evaluate the qualifications of the business:

- Capability to perform the required services for EOA Children's Services
- Professional background and experience on similar projects
- Cost of services

Proposals will be reviewed by a team representing EOA Children's Services.
